Nowadays, the Ministry of Agriculture, Forestry and Fisheries doesn't have certificate system as well as standards of agriculture, aquaculture, poultry, food processing products, animal feeds, natural organs with no synthesis and antibiotics. In addition, there is no institution other than the agro-industrial department through Prakas No.358, which is capable of carrying out all tasks as a package. Moreover, the demand for quality and safe agricultural products, as well as compliance with right monitoring of Prakas No.334 is in great demand because some agricultural products in the market cannot guarantee the quality and safety for consumers. This project will be an effective mechanism, monitoring, assessing, quality analyzing, safety of agricultural, agro-industrial products at one place and an easy-to-use feature for manufacturers, distributors, users, and developers to access the services from specialists from various institutions as needed.

15. PROJECT JUSTIFICATION: (Give reasons why this particular project is considered worthwhile.)

People at all levels are concerned about fraud, unfair competition, quality, safety of agricultural, agro-industry products. Based on Prakas 358 on and Prakas No.334 on Sub-Decree 105 and beyond the scale of agro-industrial department can be worked as a package on agricultural, agro-industrial products including agricultural products, aquaculture, poultry, processing, quality and safely monitoring, etc.
