Both relevant stakeholder at national level and sub-national level and development partner had prioritized on the prevention of violence and child abuse by fulfilled its obligations under the UN Convention on the Rights of Children.

15. PROJECT JUSTIFICATION: (Give reasons why this particular project is considered worthwhile.)

Based on the results of a national study on violence on children of the Ministry of Women's Affairs in 2014 (CVACS), children and 2,376 young people, aged between 13-24 were questioned about their experiences related to physical, emotional and sexual violence before the age of 18. CVACS findings was highlighted as follow:

- **More than 50% of all children suffer physical abuse. Those children memorial from being punched, kicked, beaten with rods or something.**
- **A quarter of children suffer psychological abuse by parents, caregivers or other adult relatives.**
- **Mortal parents who abuse: Most children reported that their father or mother is doing things the first physical violence, especially mothers.**

The mother, who was also frequently quoted people who commit physical violence incident first.

- **In general, children exposed to violence at home: Among children aged between 13-17, notoriety of physical violence at home, in which 37.4% of girls and 34.7% boys reported that they had witnessed physical violence within the last 12 months.**

Positive Parenting plays an important role in the prevention of violence and the core of the child's optimal development. A stable family life and secure excluding positive relationships with parents or caregivers is very important for children to succeed at schools to have good relations with the others and to become adults productive in the long-term future in society. Positive parenting can prevent children suffering from complications caused difficulties and other negative life, including poverty and violence. Those point indicated the importance of providing parents and caregivers with support for positive parenting.
