The rehabilitated roads will provide rural vulnerable communities with better accessibility and more opportunity for their socio-economic development. The project will also support the sustainable development of agricultural rural area and enhance effectiveness of rural transport infrastructure as well as reduce the government's burden for costly maintenance expenses.**
