 - Undertake archaeological excavation to study structure foundation and deposited soil
 - Restore ancient drainage system to refunction

 - Dismantle ancient stone pieces/blocks, test strength of staircase foundation, remove deposited soil, compact staircase foundation and test strength of staircase foundation after compaction
 - Repair ancient stone pieces/blocks, reassemble and fix cracking area

The northern ancient staircase is in sever condition as a result of lack of maintenance for hundred years and environment factors caused by penetration of tree roots and rainwater. If no immediate restoration is carried out, the staircase will face further damage and result in loss of heritageg value of the Preah Vihear temple. The restoration of the northern ancient staircase is to refunction ancient infrastructure to normal; bring back authenticity of the staicase; place lion sculptures at their original positions, all of which contribute to value addition of the northern ancient staircase as well as support tourism sector.
