The overall objective of this project is to contribute to a well-functioning labour market and to support skills development and employment for youth in Cambodia. The project will contribute to the implementation of the Youth Strategy endorsed by the Royal Government of Cambodia in June 2011 and to the implementation of its Programme Plan 2012-2015. Overall, it will also contribute to the implementation of the employment and skills development related objectives defined in the National Strategic Development Plan (NSDP) Updated 2009-2013.

The project components are tightly interlinked and very much depending on each other. The basic idea with the project design is to support policies and strategies endorsed/decided by the Cambodian Government in the field of skills development and employment for youth. An essential part is to support and facilitate public private partnerships and to bridge education and skills development and the needs of the labour market. These interventions will be combined by strengthening of the capacity of NEA and by implementation of direct actions e.g. training programmes/skills development for youth in rural areas. The three components as following:

- Coordination and support to the implementation of the National Youth Strategy and the Programme Plan 2012 2015
- Strengthening and further development of National Employment Agency (NEA)
- Actions to support skills development and entrepreneurship for youth in rural areas

The project started in Feb 2013 and finished on August 2015 (2.5 years) with support from Swedish International Development Cooperation Agency (SIDA) through technical support from Swedish Public Employment Services (SPES).

The basic idea with the project design is to support policies and strategies endorsed/decided by the Cambodian Government in the field of skills development and employment for youth. An essential part is to support and facilitate public private partnerships and to bridge education and skills development and the needs of the labour market. These interventions will be combined by strengthening of the capacity of NEA and by implementation of direct actions e.g. training programmes/skills development for youth in rural areas. It is first initiative project that link between NEA and Ministry of Education, Youths and Sports working together through the establishment of Youth Career Guidance Unit. The establishing of the Youth Career Guidance Centres in rural areas can be a powerful tool in order to reach the rural youth with adequate information. These centres provide educational and vocational information and guidance to students on various levels of the education system and to job-seekers. Reliable information on the trends on the labour market should be a part of the training curricula and should be organized for students in strong cooperation between schools, private sector and the NEA.

the implementation has been in general very good and the project is likely to achieve a number of the results expected until August 15, 2015. However, it is also obvious that there is a need for more time in order to achieve:

- The overall objective of 7 000 employed
- The establishment and sustainability of the Youth Career Guidance Units in the provinces
- The target of to provide vocational guidance for 1000 young women and men in the provinces
- The target of 500 young women and men participating in the Internship Programme
- The implementation of the Soft Skills Training Package and the target of 800 participants

One reason for the need for more time is the delay of establishing the new centres and another reason is the challenging concepts that have been developed by the project, such as:

- The Youth Career Guidance Units including the active cooperation between MoEYS and NEA
- The occupational forecast
- · The enhanced service model
- Active measures for to support young job-seekers with disabilities

All in all, the main conclusion is that a strong common platform of successful cooperation is now established, but the project timeframe has to be extended.
