The economic and employment situation of disadvantaged rural households in selected provinces has improved.

The Program will be implemented in the provinces of Banteay Meanchey, Oddar Meanchey, Preah Vihear and Siem Reap (value chain tourism only).

In March 2021, the achievement of the Program objective is to be measured by the following indicators:

- 1. 20% of 30,000 rural households including identified poor households (ID-Poor) according to their share (around 16%) in the respective reference area (province) who are supported by sub-national administrations confirm that their (a) economic situation or (b) employment situation has improved by 1 level on a scale from 1 to 5.
- 2. Out of 10,000 supported family farms 6,000 have increased their household income from farming by an average of 10% (among them: 20% ID-Poor).
- 3.750 new employment opportunities are generated for rural areas (among them: 50% women; 25% ID-Poor) and among these the newly closed formal employment contracts run for at least 6 months and satisfy the minimum wage condition.
- 4. 40% of 500 supported women-led households indicate that their social situation has improved in two of the following aspects: (a) more balanced diet, (b) regular schooling of the children, (c) improved health care, (d) investment in housing, and acquisition of (e) production or (f) long-life household goods.

RED IV Implementation Progress as of December 2019:

Component 1: Addressed the ability and capacity of the public administration on provincial, district and municipal level to design, plan and implement local economic development policies. In 2019, four new LED sub-committees have been established. So far, seven LED sub-committees exist, two of them in BMC, two in OMC and three in PVH. It is expected that other districts will follow. To support the work of the LED sub-committees a study trip to Germany was organized with the members to share experiences and look for good practices. Component 2: Focused on the promotion of micro, small and medium enterprises (MSME), employment promotion and the improvement of skill sets through technical and vocational training and education (TVET). RED IV facilitated throughout the year 2019 MSME trainings on business planning, sales & marketing, finance management, accounting and taxation. A total of 234 participants from 134 MSMEs were trained. 30 MSMEs were selected to receive intensive coaching from business trainers. In terms of Tourism, RED IV provided tourism relevant skills as well as community-based tourism management to local communities in targeted districts such as training classes in hygiene, health, food safety, hospitality, food preparation and restaurant management. Component 3: Supported a variety of program partners, particularly PDAFF and DAO, in their efforts to increase the competitiveness of the rice, cassava and vegetable value chains. The program also facilitated the founding meeting of the "Cassava Innovation Platform NW Cambodia" which took place on 14th of August 2019, 136 representatives from the public and private sector as well as development agencies and NGOs participated in the event, Between January and December 2019, 1812 cassaya farmers participated in a comprehensive modular training on sustainable cultivation techniques. 2095 (1545 BMC, 547 OMC) rice farmers participated in a comprehensive 3-module training on sustainable cultivation techniques. Between January and December 2019, 321 (276 BMC, 10 OMC, 35 PVH) vegetable farmers participated in trainings on advances vegetable cultivation techniques. In 2019, the program further optimized its training concept and is now offering custom made training modules that best meet the specific demand of the vegetable farmers. Component 4: The work area of "Special Measures and Gender Promotion" was established as a cross cutting function from the start of RED VI. It is the aim of RED IV to establish mechanisms and mainstreaming strategies

It is the aim of RED IV to establish mechanisms and mainstreaming strategies to ensure that gender issues are incorporated into the work plans of all components and to monitor the implementation of those plans from a gender perspective. The Program facilitates dialogue on gender related aspects of LED in relation to relevant stakeholders from the public sector, private sector or civil society.
